An intern is needed to assist the Department of General Services' Division of Sustainability, which is housed in the Center of Responsible Energy (CORE). The intern will work with the Assistant Director of Sustainability and the sustainability team on a variety of projects and outreach and educational initiatives. Projects may focus on energy management, renewable energy, waste reduction, electric vehicles, and/or Metro-wide educational campaigns and community engagement for *Socket, Nashville's Sustainability Outlet*.

Intern Responsibilities include:

- Assist sustainability staff with the creation and coordination of initiatives city-wide
- Help develop workshop curriculum on sustainable behaviors
- Assist with website content and social media outreach
- Help plan and execute presence at public outreach events
- Help document, record, track and review energy and waste data and trending
- Research and report on sustainability practices locally, regionally and nationally
- Innovate ideas for sustainability programs and messaging campaigns

Requirements: Student must be a rising college Junior or Senior or Graduate Student. Student must be able to work 15+ hours per week during regular business hours – Monday-Friday, 8am-5pm – for a minimum of 10 weeks, June – August. Student is encouraged to receive course credit for the experience, but not required. This internship is unpaid.

Applicants must submit

- Professional resume
- Two letters of recommendation – one from a school faculty member and one personal or professional recommendation from someone other than a relative
